The year 2021 was legendary. We awarded 51 scholarships, which doubled the 25 scholarships we awarded in 2020. In addition, we awarded \$82,100 to single mothers in Utah, which nearly doubled our scholarships awarded in 2020 from \$45,000. We are incredibly grateful for the support from donors, sponsors, and the local community; we would not be successful without your help!

We had another sold-out golf tournament! Congratulations, ASEA, for winning this year's Tournament! We had the most Scholarship Sponsors ever at our golf tournament. OUR IMPACT

Live Your Dream supports women and children in Utah. Since our

inception in 2010, we have awarded 160 scholarships to single mothers who desire to attend college, university, technical school, Bootcamp, or any education that will increase their earning potential to help them better provide for their family. We award scholarships in the fall and winter/spring. All recipients go through an application process and can apply for a scholarship multiple times.

Because of the scholarships awarded to single mothers since our inception, over **392** children have a greater probability of gaining a higher education.

Gaining a college education impacts families, friends, and communities for generations to come. Children with mothers who have a higher education are more likely to attend college, participate in civic activities, and be more involved with their future children (Women and Education Initiative Madsen, 2010).

We are also helping to break the poverty cycle in our community. According to the US Census Bureau reports, 40% of all single mothers live below the federal poverty level. The DWS reports, "Obtaining a quality education increases employment opportunities, increases lifetime earnings, and supports economic stability for parents and their children."

Major & School: Interior Design at Weber State University

Estimated Graduation Date: April 2022

Impact on Kids: Going to college will allow me to get a full-time job I love. It will make me self-sufficient; I won't have to worry about how I will take care of my two boys. I wanted to be an example to them that no matter how hard life can be, we can always do hard things and become better for it. My boys are my strongest supporters and are so proud of me. I definitely can see them gaining higher education in their futures.

"I was able to receive two scholarships through Live Your Dream. This organization helped me so I could focus on my education and my two boys. Receiving two scholarships for my tuition and other resources from their service projects allowed me to have money for books, projects, gas, food, and peace of mind. I was lucky enough not to have to work while going through school, so these scholarships were a huge help."



Beth Obrien

Major & School: Master's degree in Social Work

Graduation Date: April 2021

Employment: Before graduation, I worked as a mental health technician at the Utah State Hospital and as a shift supervisor at a residential treatment center for adolescent youth. Now I am working as a therapist in a private practice setting where I have flexible hours and have increased my potential to help struggling community members. I work with children, adolescents, and adults and conduct group therapy and workshops, particularly for parents. My per-hour earning potential has increased by three times since graduation, and by the end of December 2022, I will have met the requirements to obtain my license. I will be working as an LCSW which will again increase my income, I anticipate, by an additional \$30,000 per year. I no longer receive government assistance of any kind.



Impact on Kids: My children are now well provided for. They also have a mother who is far less stressed and no longer depressed, so I can parent more intentionally and tend to their needs beyond basic survival. I absolutely believe the children who are still living at home and have experienced the direct effects of the changes made possible by my education are far more likely to gain a higher education.

"It was important to gain a higher education because I was limited in my capacity to provide for my children on a single income which meant I was dependent upon assistance from the government and others. This dependence led to depression and a sense of powerlessness that further limited my ability to be the mother I wanted. I did not feel free. In addition, I wanted to be engaged in employment that I felt mattered. Becoming a therapist has given a meaningful context to all that I have been through because I can relate to my clients, which I believe makes me a more effective clinician. Live Your Dreams made it possible for me to reach my goal and improve not only my earning potential but the quality of my life and the lives of my children."

"I feel like a different person. I no longer feel limited and hopeless. Not only do I have a powerful belief in a beautiful future, but I get to meet with others daily in support of their efforts to restore hope and the possibility for change. I feel like an entirely different person than before returning to school. I am calmer and have a healthier sense of internal control, making it possible for me to release my impulse for external control. I can manage life's challenges from a much healthier perspective."



Mark your calendars for the Live Your Dream golf tournament on Thursday, June 1, 2023, at Sleepy Ridge golf course in Orem!


